Eligibility: The Firstrust Bank Eagles Brotherly Shove Business Spotlight ("Contest") is open only to privately owned, for profit small businesses that are eligible to enter this Contest ("Entrants, you or your"). Small businesses that are eligible to enter the Contest are those which are: 1) located and/or operate in Pennsylvania, New Jersey or Delaware; 2) have gross annual revenues of more than \$1 million and less than \$50 million; 3) have been in operation for at least three (3) years prior to the Contest Period; and 4) have at least five (5) full-time and/or part-time employees ("Entrants"). Entrants which are business entities must be entered by an individual with the authority to bind Entrant to these Official Rules and other terms and conditions of the Contest.

Employees, officers and directors of Firstrust Bank and its subsidiaries, Philadelphia Eagles, LLC ("Eagles"), and their immediate families (parent, child, sibling & spouse, and their respective spouses, regardless of where they reside) and persons living in the same households as such individuals (whether related or not) are not eligible to participate in the Contest. The link will ask recipients to complete an entry form to enter the Contest by providing the following information: name, address, phone number and email address, gross annual revenue and industry. (max. of 150 words) 2) In what ways does your business demonstrate a strong commitment to your local community? (max. of 150 words) 3) The Eagles are known for grit, resilience, and toughness. How does your business embody these qualities in the way you operate and serve your customers? Entrants will agree to the official rules and confirm that they are located in PA, NJ, or DE. Limit one entry per business (email address). Businesses will be asked to provide answers to the following questions: 1) Briefly describe your business, including what you do and what sets you apart. (max. of 150 words) 2) In what ways does your business demonstrate a strong commitment to your local community? (max. of 150 words) 3) The Eagles are known for grit, resilience, and toughness. How does your business embody these qualities in the way you operate and serve your customers? Limit one entry per business. Entrants must agree to these Official Rules.

- **4. Entry Guidelines:** To be eligible, the entry form must be complete. No information regarding entries, other than as otherwise set forth in these Official Rules will be disclosed.
 - Use of computer programs and other automatic means to enter the Contest is prohibited and will result in disqualification. Finalist, Honorable Mention, and Winner Selection and Notification: Five (5) finalists, five (5) honorable mentions, and one (1) grand prize winner will be selected and will be notified via email and phone by October 15, 2025 at 5:00pm ET. Selection committee will evaluate all answers to each question to determine the business that best represents the values of Firstrust Bank and the Eagles. Winners will have to meet the eligibility requirements on location, revenue size, number of employees, time in business and business/industry types as set forth in Section 1 of these rules. A rubric, selected by the Sponsor in its sole discretion, will be used to rate on a scale of 1-5 the submission details for each question

listed in Section 3 of these rules. Five (5) finalists, five (5) honorable mentions and one (1) grand prize winner will then be chosen by the selection committee.
