Eligibility:** The Eagles Checking Giveaway ("Sweepstakes") is only open to legal residents of the United States who are currently living within Pennsylvania, New Jersey, Delaware or Maryland who are 18 years of age or older at the time of entry ("Entrant"). Employees, officers, directors, agents and representatives of Philadelphia Eagles, LLC (the "Eagles"), Firstrust Savings Bank ("Firstrust Bank") and any of their respective agencies, owners, subsidiaries and affiliates, advertising and promotion agencies, wholesale distributors and individual retail licensees or the immediate family (spouse, parent, sibling, child, or grandchild, regardless of where they live) or members of their same households (whether related or not) of each such individuals are not eligible to participate or win a prize.

## 3. How to Enter:

- AUTOMATIC ENTRY: An eligible Firstrust Eagles checking/debit cardholder will automatically receive one (1) Sweepstakes entry for each eligible Visa purchase made with their Firstrust Eagles Visa® debit card, made during the Entry Period at a participating merchant location in the U.S. Only eligible Visa purchases, or payments made with a Firstrust Eagles debit card that is not in default under the customer agreement for that account and issued by Firstrust Bank, processed through Visa U.S.A. Inc.'s transaction-processing system during the Promotion Period, are eligible for automatic entry.
