Firstrust Bank Eagles Debit Card Sweepstakes Rules | 2024 Season

NO PURCHASE, ACCOUNT RELATIONSHIP OR TRANSACTIONS NECESSARY TO ENTER OR WIN. A PURCHASE OR ACCOUNT RELATIONSHIP WITH FIRSTRUST BANK IS NOT NECESSARY TO ENTER OR WIN. Void outside the states listed below. The Firstrust Bank Eagles Debit Card Sweepstakes (“Sweepstakes”) is subject to applicable federal, state, and local laws and regulations and is void where prohibited or restricted.

This Sweepstakes is in no way sponsored, endorsed, administered by, or associated with the Philadelphia Eagles. Any questions, comments or complaints regarding the Sweepstakes must be directed to the Sponsor, and not to Philadelphia Eagles.

1. Eligibility: The Eagles Debit Card Sweepstakes is only open to legal residents of the United States who are currently living within Pennsylvania, New Jersey, Delaware, or Maryland who are 18 years of age or older at the time of entry (“Eligible Entrants” or “Entrants”). Employees, officers, directors, agents and representatives of Philadelphia Eagles, LLC (the “Eagles”), Firstrust Savings Bank (“Firstrust Bank”) and any of their respective agencies, owners, subsidiaries and affiliates, advertising and promotion agencies, wholesale distributors and individual retail licensees or the immediate family (spouse, parent, sibling, child, or grandchild, regardless of where they live) or members of their same households (whether related or not) of each such individuals are not eligible to participate or win a prize.

2. Timing: Sweepstakes begins on [August 1, 2024] and ends on [July 31, 2025] (“Promotion Period”). There will be [12] Entry Periods (“Entry Period”) as set forth below.

3. How to Enter:

- **AUTOMATIC ENTRY:** An eligible Firstrust Eagles debit cardholder will automatically receive one (1) Sweepstakes entry for each qualifying Visa purchase made with their Firstrust Eagles Visa® debit card during one of the Entry Periods at any participating merchant location in the U.S. Only qualifying Visa purchases, made with a Firstrust Eagles debit card on an account that is in good standing under the Retail Account Agreement and Visa Debit Card Agreement for that account and issued by Firstrust Bank. Only purchases processed through Visa U.S.A. Inc.’s transaction-processing system during the Promotion Period, qualify for automatic entry into the sweepstakes. A purchase is processed through the system when the payment is made using a Visa® debit card and the amount is deducted from your checking account. In the event of a dispute as to who submitted a particular cardholder entry, such entry will be deemed to be submitted by the primary person in whose name the card used to enter the Sweepstakes was issued. Account adjustments may be necessary because non-Visa processed transactions, returns or non-U.S.-dollar denominated purchases, are excluded from automatic entry. Other restrictions and exclusions may apply. Visa cards or card numbers that are stolen, fraudulent, tampered with, or otherwise altered are not eligible for automatic entry. Purchases for automatic entries must be made by the last day of each monthly Entry Period to be eligible for that month’s drawing. Entries that qualify for one Entry Period do not carry over to, and are not eligible for, subsequent Entry Period drawing dates.
- **TO ENTER BY MAIL WITHOUT PURCHASE OR OBLIGATION:** An eligible Entrant can enter the Sweepstakes without being a Firstrust Eagles debit cardholder. To do so, handprint your full name, street address, city, state, ZIP code, and daytime and evening telephone numbers (including area code) on a plain piece of 3” x 5” paper, and mail it in a business-size (#10) envelope with sufficient postage affixed, to: Firstrust Bank, Attention: Marketing Department, 1 Walnut Grove Drive, Horsham, PA 19044. Entries will be entered into the drawing

for the Entry Period that occurs during the month in which they are received. Entries do not carry over to the following month, new entries must be received during each Entry Period. Entries need to be received by the last day of each Entry Period to be eligible for the drawing during that Entry Period. Entries will be accepted until July 31, 2025. Enter as often as you wish; however, each mailed entry will count as one (1) entry into the random drawing and must be mailed in a separate, postmarked-and-stamped envelope. Entries that are mechanically reproduced, copied, illegible, incomplete, or inaccurate and entries by any means which subvert the entry process are void. Entries become the property of the Sponsor and will not be acknowledged or returned. Incomplete entries or entries not complying with these Official Rules are subject to disqualification, at the Sponsor’s sole discretion. Proof of mailing does not constitute proof of delivery.

4. Sweepstakes Drawing: The random drawing of two (2) eligible entrants will be conducted on the 5th day of each month following the below schedule of Entry Periods.

By entering, you grant permission to be contacted by Firstrust Bank via email, mail, or telephone in connection with the Sweepstakes, although you may opt out of receiving such materials at any time. You must comply with all terms and conditions of these Official Rules and winning is contingent upon fulfilling all requirements set forth herein. A potential winner is not an official winner (“Winner”) until the potential winner’s eligibility has been verified and they have been notified. Sponsor’s decisions are final and binding in all matters related to the Sweepstakes.

5. Winner Notification: The potential winners will be notified by phone, mail, or email within three (3) business days of the drawing. If a potential Winner cannot be contacted or has not responded within five (5) days of being notified or he/she refuses his/her prize for any reason, such potential Winner will be disqualified, and Sponsor will select an alternate potential Winner by random drawing from all remaining eligible Entries. If potential Winner of the monthly prize fails to execute the requested documents within 14 days of receipt of notification, he/she shall forfeit the prize and an alternate potential Winner will be selected at random from the remaining eligible Entries. Potential Winner of the monthly prize will be required to sign an Affidavit of Eligibility, Liability & Publicity Release (collectively an “Affidavit”), a W-9 form containing the potential Winner’s Social Security number, and any other legal documents that Sponsor may request. In the event of a dispute as to any entry, the authorized account holder of the e-mail address used to enter will be deemed to be the entrant. Each potential Winner may be required to show proof of being the authorized account holder of the e-mail address used to enter.

6. Prize: Two (2) prizes are awarded following each Entry Period. Each prize is pre-determined for each date. Approximate value of each prize is listed below. Seat locations will be determined by Sponsor in its sole discretion. Sponsor has the right to substitute any prize with one of equal or greater value. Transportation, accommodations,

parking, meals, gratuities, souvenirs, and all other expenses not specified herein are solely the responsibility of the winner and their guest.
